

# **Consolidated Application for Self-Exclusion**

### NOTE:

### **Declaration by Applicant**

- 1. I confirm that my employer/organisation representative has explained the following terms and conditions to me. I understand that:
  - a. My Self-Exclusion(s) takes immediate effect upon the submission of this application online.
  - b. My Self-Exclusion(s) will remain in force until such time that the Council, upon my application, revokes it. If I decide to revoke my Self-Exclusion(s), I agree to do so only after 12 months from the date my Self-Exclusion(s) takes effect.
  - c. The National Council on Problem Gambling ("NCPG") will not be responsible for any injury, damage or loss arising from this application or failure to enforce the Self-Exclusion(s).
  - d. When I apply to revoke my Self-Exclusion(s), the Council may, as a condition of revoking the Self-Exclusion(s), refer me for problem gambling assessment(s) and counselling.

## Self-Exclusion (Casino)

- e. If my Self-Exclusion has come into force, I will be banned from entering or remaining on all casino premises; or taking part in any gaming in all casino premises.
- f. All levies, if applicable, paid by me, are not refundable under any circumstances.

#### Self-Exclusion (Jackpot Machine Rooms)

- g. If my Self-Exclusion has come into force, I will be banned from entering or remaining on all jackpot machine rooms<sup>1</sup> in private clubs except to perform work<sup>2</sup> within any of those rooms; or taking part in any gaming in all jackpot machine rooms in private clubs.
- h. My Self-Exclusion will take effect across all jackpot machine rooms in Singapore regardless whether I am a member of any of the private clubs at the time of this application.
- i. The NCPG will disclose information to private club(s) on whether I have Self-Exclusion from all jackpot machine rooms in Singapore, upon the request of the private club(s) at the point of my entry into a jackpot machine room.
- j. Private clubs operating jackpot machine room(s) will enforce the Self-Exclusion.

# Self-Exclusion (Singapore Pools)

- k. If my Self-Exclusion has come into force, I will not be able to access Singapore Pools account-related<sup>3</sup> services if I am an existing account holder; and I will not be able to open an account subsequently if I am not an existing account holder.
- I. The NCPG will disclose information to Singapore Pools if I have Self-Exclusion from Singapore Pools Account.
- 2. For the purposes of this application, I consent to the NCPG obtaining my necessary particulars from the relevant authorities.
- 3. I understand that legal action may be taken against me if I have given any false information in this application.
- 4. I understand that by providing my contact information, I consent to the NCPG contacting me regarding my Self-Exclusion(s), responsible gambling practices and research.
