**NCPG GETS READY TO IMPLEMENT CASINO EXCLUSIONS**

-- NCPG Issues Annual Report for 2007/2008 and  
Maps Out New Workplans Ahead --

The National Council on Problem Gambling (NCPG) concluded the first year of its second term recently on 31 August 2008, and signals its preparation for the implementation of the NCPG casino exclusion orders in the coming year.

Said Mr Lim Hock San, Chairman of the NCPG: "The first casino is expected to open in the third quarter of 2009. We would start receiving applications for casino exclusion measures by January next year. We hope to minimise the number of Singaporeans who suffer from problem gambling."

Under the Casino Control Act, the NCPG has the authority to issue casino exclusion orders. The NCPG expects to start issuing some 29,000 exclusion orders next year. Excluded persons will include all undischarged bankrupts and those on public assistance. Families may also apply for their members to be excluded if they have a gambling problem. Individuals may voluntarily apply for exclusion. The NCPG hopes to be able to start receiving applications for casino exclusions from January 2009.

The Casino Control Act requires the NCPG to appoint a Panel of Assessors (POA) to decide on applications for the family exclusions. Two members from this panel and one NCPG council member will then form the Committee of Assessors (COA) to decide on and issue the casino exclusion orders.

The NCPG has shortlisted some 60 grassroots leaders and social service professionals to join the POA. Several have confirmed their participation. The NCPG is looking to appoint at least 40 of them at the onset, as the caseload of applications for family exclusions are not known. These candidates are selected based on their age and maturity, years of experience in the social or community service, the ability to make proper and fair judgement, and minimum academic qualifications of O-levels and above.

In the year that passed (September 2007 to August 2008), the NCPG focused on ramping up its public education efforts, particularly through mass media initiatives. It appointed a professional communications agency for the first time since its establishment in August 2005. The advertisement, which has featured a little girl protecting her piggy bank from her problem gambler father, has been well received. The campaign was executed in several bursts throughout the year, via an integrated media platform especially through TV and radio. The creative

campaign has also won a bronze award under the 'Best Cause or Charity Marketing Campaign' at the prestigious Promotion Marketing Awards of Asia (PMAA) 2008.

The same concept has been replicated in the NCPG's public education collateral disseminated through gambling outlets and community partners. Some 70,000 pieces of collateral in the form of posters, brochures, pens, stickers and decals were distributed to the 16 gambling operators who have signed onto the NCPG's voluntary Responsible Gambling Code of Practice.

The Council also rolled out two pilot runs of a training programme for 60 frontline staff of these gambling operators so far, and is expected to help train another 1000 of these personnel over the next two years. In the coming year, the Council hopes to encourage at least 80% of the 106 gambling operators here to sign on. This list includes predominantly private clubs with jackpot machines.

The NCPG will be sharing more details of its casino exclusions and responsible gambling work in the next few months.
